
#### How do I make a submission? How do I tell you what I think?

The main part of the submission should include details on what aspect of heritage you are interested in and what action you think needs to be taken.

#### What happens then?

A draft heritage Plan will be written. This plan will be put on public display. You can then see how you opinions or ideas have been taken into account. There will be a public workshop to discuss the Draft Heritage Plan. You can then comment on the draft plan.

Once a final Heritage Plan has been written, it will be presented to Kildare County Council for adoption. We then start carrying out the actions.

### KILDARE HERITAGE PLAN CONSULTATION 2013

Kildare County Council and Kildare Heritage Forum are beginning the process of writing a new Heritage Plan for County Kildare and would like to hear your views on what actions should be contained in the new Plan.

If you are a member of a community group, tidy towns group, historical society or wildlife group or an individual interested in the heritage of County Kildare you are invited to make a submission to the new Plan by the 12th April 2013.

If you make a submission you are ensuring that the specific views of the people of Kildare are considered in writing the plan. The submissions made will feed directly into the draft Heritage Plan. The draft plan will be put on public display for a period of 5 weeks, during this time the public will be able to comment on its content.

# What is Heritage?

In the context of the 1995 Heritage Act, the term Heritage is considered to encompass "monuments, archaeological objects, heritage objects, architectural heritage, flora, fauna, wildlife habitats, landscapes, seascapes, wrecks, geology, heritage gardens and parks and inland waterways".

Heritage, therefore, can be considered to be our inherited traditions, monuments, objects, and culture. Heritage is both the tangible and intangible. It is how we identify ourselves and define a sense of place.

Heritage includes natural heritage such as flora, fauna geology, wildlife areas, landscape waterways and biological diversity.

It includes built or man-made heritage such as demesne houses, vernacular architecture, monuments, archaeology,



# What is a County Heritage Plan?

A County Heritage Plan is a series of actions compiled from input from organisations and individuals who have an interest in the heritage of County Kildare. It is a five year document, which details how heritage in the county shall be managed and protected on a partnership basis. It is an opportunity to identify heritage issues and heritage needs at a local level and to address them locally within a national framework.

The writing of a heritage plan is overseen by the County Kildare Heritage Forum, which is made up of organisations or individual within the county who work in the area of heritage or have an interest in heritage.

The aim of the current heritage Plan is "to identify, preserve and conserve the built, natural and cultural heritage of the county". The first County Heritage Plan was published in 2004 and contained the following objectives:

- To facilitate the collection and dissemination of heritage information.
- To raise public awareness, understanding and appreciation of County Kildare's heritage.
  - To promote best practice in heritage conservation and management.
    - To inform policy and provide advice to County Kildare Local Authorities.

Specific actions were then detailed under each objective. A similar approach will be used in drafting the new Heritage Plan. You are invited to help define the objectives of the new plan and to help prioritise areas for action in the new Plan which will be from 2014-2018.

# What has been done already?

An independent review of the existing Heritage Plan was undertaken in 2011 which made a number of recommendations for the new plan preparation. The current Plan contains 85 actions and some progress was made on the implementation of 72 of these actions. Here is a flavour of some of the projects carried out:




